	_	Doug would like to request a new budget item to make the forum ad free for \$30/year
		We could also personalize the URL and have it ad free for \$45/year
		■ We may not need it as many students have ad-block
		■ But it would look much more professional to those who do not
	0	We could trial this for 1 year, then administer a survey but it would be better to keep the URL consistent
	0	May be better to make the website as professional as possible from the beginning in anticipation of its growth to include preceptors and faculty members in the future
	Motion:	Be it resolved that APSA Council approve a one-time budget item of \$45 for the purpose of
	making	the Student Accommodation Network forums ad free and have a personalized URL for 1 year.

>	Yearboo	ok Update - Publications Director
	0	Yearbook sales have not been very high and little interest has been shown in them
	0	Alyssa suggests changing the format of the yearbook
		 Have a personalized yearbook for each graduating class that follows them through their four years of pharmacy school
		 Other schools had trouble selling yearbooks but this system as very successful for them
	0	The logistics and the constitution will still have to be figured out
	O	This could either start with the class of 2017 or 2018
		Councillors felt this should start as soon as possible and try to have this new
		system in place for the incoming class of 2020
		It could become the responsibility of the class reps and social reps to coordinate this
		for their class
		The yearbook will still be under the direction of the Publications Director
	0	Starting now would mean extra work but this is an opportunity to trial the new system
		■ The incoming class of 2020 could have two designated students coordinating the yearbook for the four years
		 Another option is to have two students coordinate the yearbook as well as sit on the
		Publications Committee
		■ We could create an ad-hoc committee for the class of 2017 to start the project
	0	Earlier availability is not possible at the moment due to the printing date being in August
		Images of Distinction has not sufficiently met APSA's needs and council is considering changing
		to <u>Lifetouch</u> when the current contract expires
>	APSA/R	«A Flu Shot Video and Contract - SAF-Pharm Director
	0	<u>Contract</u>
	0	RxA would like to contract APSA to create a video for their Fall 2016 flu campaign
	0	APSA will contract Jordon Hon to produce the video now for later release Total estimate is \$280
		2 days of filming, 3 hours per day, at \$30/hr and a \$100 flat rate for editing
		■ APSA will pay Jordon Hon first, then invoice RxA for reimbursement later
	0	This video is projected to be completed before the end of the school year
	Ō	We will receive invoice and pay within 3 days, then hold the deficit until APSA is reimbursed by RxA
	0	There are current plans to shoot the video in several weeks

O This contract will be a one-time budget item

- O APSA will specify a deadline for submission of the final product
 - This will then be shared with RxA for review
 - Tentative deadline is May 31, 2016 but Daniel will discuss this further with Jordon

Motion: Be it resolved that APSA Council agree to the terms and conditions laid out by the contract between Jordon Hon and APSA for his services on the APSA/RxA Influenza Immunization Awareness Video. The contract will be signed by Helen Marin (President) and Roy Tram (VP Finance) on behalf of APSA. First by Kevin, seconded by Doug. All votes in favour, motion carries.

- Pharm 453 Intercultural Exploration of Pharmacy and Health President
 - O Students taking pharm 453 are usually reimbursed \$750 per person through the U of A group awards
 - This year, Professor Cox was unable to secure this funding for the class and requested students apply for the individual award instead
 - 9 students were declined for this award and were wondering if APSA could help
 - O Helen discussed this funding with Dean Kehrer and agreed that if APSA approved of this funding coming from the MMF, he would allow it
 - There is usually extra unused money from the MMF and the funds would be coming from that leftover money
 - Students will have to keep receipts and submit the required documents to receive this funding
 - O Council felt that considering that these students were told by the Faculty they would get support but did not, APSA should support them if possible

Motion: Be it resolved that APSA Council approve a one-time payment of \$6750 from the market modifier budget to the 9 students that did not receive the expected travel award ($$750 \times 9$) upon successful submission of required documents. First by Alyssa Aco, seconded by Kevin. All votes in favour, motion carries.
