## New Business:

- 5. VP Fundraising Revisitation (10 min) Sam
  - a. <u>Presentation</u>
  - b. Sam I have really tried to build and define my position, which I want to outline in my transition document so that it is carried forward in future years. Considering the amount of work that will be done from now on, there should be a change in the constitution so make the workload manageable and ensure efficient communication. I spend a lot of time sending emails to council members and getting contact information, and then relaying information back and forth. This could be changed by making an ad hoc fundraising committee, create a position on PAM and Movember committee for a silent auction representative, change it to an executive position, or leave it as it is all on an ad hoc basis for next year. I think making it an executive position or adding silent auction representatives to committees would be best.
  - c. Ayush A VP Position may be helpful in the future if faculty funding continues to be cut as they have been.
  - d. Scott So we would have to vote on this today, and then tell candidates it wouldn't officially be decided until the AGM, and then there would need to be a written document for the Constitution and Policy Committee. We will do a ranked vote, with all 4 options and then eliminate the least popular until there is only one option left.

      - *Motion:* To run the position as VP Fundraising for the coming year.
