10. Single Source Beverage Agreement Consultation - Gauhar (5 mins)
 - a. Description: A student who is organizing a plebiscite question reached out asking for APSA's opinion on the U of A's agreement to only use Coca Cola products during school events. Looking for feedback/opinions on the current agreement.
 - b. Notes: Some councillors expressed that they didn't know about this agreement. Explained that we are eligible to use the "Coca-cola activation fund" where SU will provide free coca-cola beverages for one APSA event per fiscal year. Some expressed that it's nice to have the activation fund so they aren't opposed to the agreement as it is, others are concerned about not being in adherence to the agreement (ex. Having water bought by sponsors that is not specifically Dasani) and what the consequences of that might be moving forward.
