

# Semesterly Report Fall 2022 Talia Santarossa, VP Fundraising (Class of 2025)

## May-August:

- Completed role transition with the outgoing VP Fundraising

#### **Closing Notes:**

The summer and the fall semester were full of challenges and opportunities. Because of COVID, many of the connections that APSA had with sponsors had been lost, and we were left in a position of needing to rebuild connections essentially from scratch. APSA's financial situation came to light over the summer, and it became clear how important it was for us to to seek external funding.

Unfortunately, due to how extensive the changes to the Sponsorship Package were, the fact that the budget was being built concurrently (major props to VP Finance, Julia Tran), and that we needed to collect event descriptions and rough timing from Councillors, I was unable to reach out to sponsors starting in the summer, which posed a significant challenge to acquiring sponsorships before events began.

However, between the outreach that I spearheaded and the hard work of other Councillors leveraging their personal connections, we still secured approximately \$10,000 in external sponsorship and a significant amount from the Faculty, with other sponsorship pending for next semester.

I am proud of what was accomplished this semester considering the circumstances that I encountered entering this role. Given the experiences that I have had, my focus for next semester is to create fundraising policies and procedures to make my successor's job easier and to ensure that we have a groundwork for maintaining relationships with our current sponsors for years to come.
